 Where relevant, the rebate is applicable from the month following the completed application.

The application will be considered on the basis of the following documents:

- Full 2021 ICC/IFD tax statement (local-council, cantonal & direct Federal taxes) with assets declared (attach both sides of all pages).
- Certified statements of all bank and/or post office accounts referring to savings and interest as at 31.12.2021.

### SPECIFIC SITUATIONS

#### PCFAM – SUPPLEMENTARY FAMILY BENEFITS

Persons who are in receipt of cantonal supplementary family benefits (PCFam) during the school year under way **are not entitled to a reduction**. In this case, invoices can be reimbursed if they are sent directly to the *Service des prestations complémentaires* (SPC; Supplementary Benefits department).

#### HG – HOSPICE GÉNÉRAL

Persons who are in receipt of financial assistance from Hospice Général should approach their social worker directly, who will contact the *Service des affaires sociales et du logement* on the basis of certified statements of financial resources.

#### CHANGE IN CIRCUMSTANCES

If your tax statement does not accurately reflect the school year under way following the loss of a job, separation/divorce, death, etc., please contact the *Service des affaires sociales et du logement* directly.
